SCOPE OF WORK

The scope of work includes the supply of waterproofing chemicals and materials from approved manufacturers, providing the required manpower, tools and equipment, and carrying out all preparatory works at the proposed area including thorough cleaning of the surface. The work also includes the application of six layers of waterproofing coating as per the approved specification and standard engineering practices.

1. Site Inspection and Method Statement

The contractor shall visit the proposed site and conduct a detailed inspection of the area before commencement of the work. Based on the site conditions, the contractor shall submit a detailed proposal including the methodology, procedures, materials to be used, and the sequence of execution of the waterproofing work. The details should be submitted with the tender document.

2. Quality Assurance

The contractor shall ensure that the entire work is carried out with high quality standards in accordance with established engineering practices and technical specifications. Proper supervision shall be ensured during the execution of the work.

3. Use of Approved Materials

The contractor shall ensure that only approved makes and standard quality waterproofing chemicals and materials are used for the work. Necessary product details, technical data sheets, and approvals shall be submitted if required.

4. Surface Preparation and Cleaning

All preparatory works including cleaning of the surface, removal of dust, debris, loose particles, algae, old coatings or any other foreign materials shall be carried out by the contractor to ensure proper adhesion of the waterproofing layers.

5. Manpower, Tools and Equipment

All manpower, machinery, tools, tackles, and equipment required for the proper execution and completion of the above-mentioned work shall be arranged and provided by the contractor at their own cost.

6. Application of Waterproofing Layers

The contractor shall apply six layers of waterproofing coating in accordance with the manufacturer's instructions and approved specifications to ensure effective waterproofing and long-term durability of the treated surface.

7. Issue a guarantee certificate

The contractor should issue **10 years** valid guarantee certificate in favour of Managing Director, Meat Products of India Ltd.

1. PRE-QUALIFICATION

- 1.1 Sealed Tenders are invited from competent Contractors/Agencies for the water proofing works .All the tender conditions stated herein shall be valid till the contract period end.
- 1.2 The contractor shall submit a detailed proposal including the methodology, procedures, and materials to be used, and the sequence of execution of the waterproofing work.
- 1.2 **Contractors/Agencies who have experience of 3 years in field of water proofing will be eligible to submit offer against this tender.**

1.3 The qualification and experience of the firm shall be submitted along with the bid and qualification of the bid will be evaluated based on the compliance of the same.

2.0 GENERAL CONDITIONS OF CONTRACT

2.1 Validity of offer

The offer shall be valid for three months from the date of opening.

2.2 EMD

Contractor/Agency shall submit an EMD as specified in the Tender Notice as cash or Demand Draft from any Scheduled Bank drawn in favour of MANAGING DIRECTOR, MEAT PRODUCTS OF INDIA Ltd, payable at KOOHATTUKULAM. The EMD of unsuccessful tenders will be re-funded after issuing the work order to the eligible bidder.

2.3 Rates

The rates quoted shall include all the GST/taxes applicable to the AMC. **Statutory obligations like ESI, Provident Fund, Insurance, Medical expense / claim due to any accidents etc., of the personnel employed by the Contractor/Agency shall be met by the Contractor, and MPI shall not be held liable nor responsible for any such defaults.**

TDS shall be deducted from the Contractor's bills as per rules.

The rates shall be firm for the period from the date of the award of contract and no escalation will be allowed.

2.4 Security Deposit

The successful bidder has to submit a Security Deposit of amount equal to the 5% of the awarded value equivalent (minimum of Rs.25000) is retained for 1 year by way of cash, account transfer or DD from any Scheduled Bank in favour of MPI Ltd, Koothattukulam within 7 days of receipt of the work order. The Security Deposit will be refunded after one

year from the date of completing the work. The contractor should submit a valid guarantee certificate for 10 years along with the final bill.

2.5 Payment

The contractor has to right to claim 50 % of Advance payment .The advance payment will be claim after receiving the required materials at company premises. The Contractor/Agency has the right to claim the advance payment only after submitting proforma invoices or valid bills and the final payment will be made within 10 days of receipt of the final bill subject to verification of service. The contractor should produce the bill/invoice .All the statutory taxes and duties will be deducted from each bill.

2.6 Tools and testing equipment

All the necessary Spares, Materials, and Consumables required will be provided by for maintenance and commissioning work should be arranged by the contractor. All tools, tackles, top up &, testing equipment and accessories as required for the work shall also be provided by Contractor at his own cost. Travel expenses should also met by the contractor.

2.7 Details of the technicians

List of technical staff, their qualification /experience and details of in – house facilities should be submitted along with the tender. The service provided by each person engaged by the Contractor/Agency shall be satisfactory to MPI.

2.8 Assignment

The rights and obligations arising out of this agreement shall not be assigned or transferred to a third party without prior written consent of either party.

2.9 Completion of work

On completion of the work, the Contractor/Agency shall handover all the materials belongings to MPI representative and the Contractor shall

remove all materials belonging to him including the workforce without any delay.

2.10 Force Majeure

If performance by either party of its duties and obligation under this agreement is prevented or delayed by circumstances of force majeure including, but not limited to fire, flood, earthquakes, strike, war, riots, insurrection, any action undertaken or restriction imposed by authority of any Government agency or court, shortage of equipment or raw materials or any other act beyond its reasonable control, the time within which the affected party must perform shall be delayed for a period under such circumstances to a maximum of 120 days during which the parties shall use alternate methods, but after which period either party shall have the right to terminate the agreement. Determination of this agreement shall not relieve either party from the payment of the sum or performance of other duties and obligations, which may be owing to the other, as a result of the operation of this agreement prior to such termination.

2.11 Termination

Notwithstanding anything contained herein, either party to this agreement shall have the right to terminate this contract by giving the other party 30 days notice in writing.

If the service of the Contractor/ Agency is found to be not satisfactory, the contract will be terminated with one months notice and the Contractor/Agency will not be eligible for any compensation on this account.

2.12 Settlement of Disputes

Any disputes with respect to this contract shall be settled amicably as far as possible and disputes that could not be amicably settled, shall be left to the decision of a sole Arbitrator appointed by the Managing Director, MPI.

The Arbitration proceedings will be held as per the Arbitration Act then in force.

2.13 Jurisdiction

Any dispute connected with this contract shall fall within the jurisdiction of Courts at Ernakulam.

Guarantee and Liability Clause

1. The contractor shall issue 10 years valid Guarantee Certificate in favour of the Managing Director, Meat Products of India Ltd., covering the quality of materials supplied and the workmanship executed under this work. The guarantee shall remain valid for the period specified in the work order.
2. During the guarantee period, if any defect, failure, leakage, damage, or deficiency is noticed in the work due to defective materials, poor workmanship, or improper execution procedures, the contractor shall rectify the same immediately at their own cost and risk.
3. The contractor shall attend to and complete the rectification work within the time period specified by Meat Products of India Ltd. after receiving written or verbal intimation from the authorized officer of the company.
4. The contractor shall not have any right to claim any additional payment or compensation for carrying out such rectification work during the guarantee period.
5. If the contractor fails to carry out the rectification work within the stipulated time, Meat Products of India Ltd. shall have the full right to execute the rectification work through any other agency at the risk and cost of the contractor, and the expenses incurred shall be recovered from the contractor's pending bills, security deposit, or any other amounts payable to the contractor.
6. In case of failure, negligence, or non-compliance with the above conditions by the contractor, Meat Products of India Ltd. reserves the right

to initiate appropriate legal proceedings as per the applicable laws of India for recovery of losses or damages caused to the company.

7. The company also reserves the right to terminate the contract, forfeit the security deposit, and blacklist the contractor/firm from participating in any future tenders or works of Meat Products of India Ltd., without issuing any further notice.

Arbitration Clause

8. In case of any dispute or difference arising out of or in connection with the execution of the work or interpretation of any terms and conditions of this work order, the matter shall be referred to arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996, or any statutory modification thereof. The decision of the arbitrator appointed by Meat Products of India Ltd. shall be final and binding on both parties.

Jurisdiction Clause

9. Any legal proceedings arising out of this contract shall be subject to the jurisdiction of the competent courts at Ernakulam, Kerala only.

Defect Liability Period (DLP) Clause

10. The Defect Liability Period (DLP) for the work shall be 10 years from the date of completion and handover of the work, as certified by the authorized officer of Meat Products of India Ltd.
11. During the Defect Liability Period, the contractor shall be fully responsible for the performance and durability of the work executed. Any defects, damages, leakages, or failures observed during this period shall be rectified by the contractor immediately at their own cost and risk.
12. Upon receiving intimation from Meat Products of India Ltd., the contractor shall attend to the defect and complete the rectification within the time period specified by the company.

If the contractor fails to rectify the defects within the stipulated time, the company shall have the right to carry out the required rectification work through any other agency at the risk and cost of the contractor, and the expenses incurred shall be recovered from the contractor's security deposit, pending bills, or any other amounts due to the contractor.
14. The completion of the Defect Liability Period shall not absolve the contractor from any responsibility arising out of defective materials, poor workmanship, or hidden defects, if such defects are discovered at a later stage

3.0 SPECIFICATION

- b. The contract period will be extended only on the basis of mutually agreed terms and conditions.
- c. Not more than one tender shall be submitted by a Contractor. More than one concern in which an individual is interested as Proprietor and/or Partner shall not submit tender against this notice. If anybody does so, all such tenders shall be liable to be rejected.
- d. The tender form shall be available from MPI's registered office at Edayar as per the dates given in the tender notice, during working hours between 9.00 am and 5 p.m.
- e. Contractors are advised to inspect and examine the site and all the proposed area and satisfy themselves before submitting their tenders. They themselves shall obtain all necessary information as to risks, contingencies and other circumstances, which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the

building and site conditions, whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed.

- g. - j. A responsive bidder is one who has the required experience & capability and who submits priced tender with EMD and accepts all terms and conditions of the specifications and tender documents without any modifications.
- k. A modification is one, which affects in any way the quality, quantity and period of service or which limits in any way the responsibilities or
